This business is carried out by five independent brands: Gold Master, Jin Dou Gold, Yin Tian Xia, Da Xiang and Yin Ru Yi, all of which enjoy leading market position and excellent brand recognition. Looking forward, Yintech is actively developing new businesses including gold based wealth management products, trading of cultural assets and trading of overseas securities, in order to provide customers with a wider range of products and services.

Founded in 2011, Yintech was listed on NASDAQ on April 27, 2016 under the ticker symbol "YIN" after pricing a US\$101.3 million initial public offering. As of the end of 2016, Yintech's market capitalization exceeded US\$1.1 billion.

Yintech is headquartered in Shanghai, with offices also in Beijing, Guangzhou, Hong Kong and Boston. As of the end of 2016, Yintech had over 4,000 employees.
